

# Contest Rules 2023

Fly Creek Cider Mill & Orchard, Inc. organizes and sponsors promotions, giveaways, and contests awarding various prizes to participants. The promotions, giveaways, and contests are regulated by Contest Rules (hereinafter "Rules"). Participation in any of these contests constitutes the Participant's agreement and acceptance of these Rules. All federal, state, local, municipal laws and regulations apply.

# Eligibility:

This Contest is open to team players who are the first from their team to trade their team pin for the Mill's pin in the checkout/register room of the Mill Store Marketplace. The Contest is only open to Players who fill out the official entry form and acknowledge they have read and understand the Rules. Employees of Fly Creek Cider Mill & Orchard, Inc., Employees of Sponsor, and other companies associated with the promotion of the Contest, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, and immediate family members (spouse, parents, siblings, and children) and/or those living in the same household of Employees are not eligible to participate in the Contest. The Pin must be the official team pin for the 2023 playing season to be eligible to win a prize.
